

CONAN SDCC WATCH AND WIN GIVEAWAY

OFFICIAL RULES

**NO PURCHASE OR PAYMENT OF MONEY IS NECESSARY TO PLAY OR WIN.
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

OPEN ONLY TO ELIGIBLE LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES AND DISTRICT OF COLUMBIA WHO, AT TIME OF GAME PLAY, ARE AT LEAST EIGHTEEN (18) YEARS OF AGE AND WHO ARE TBS CABLE SUBSCRIBERS AS OF JULY 17, 2019.

VOID IN PUERTO RICO AND WHERE PROHIBITED OR RESTRICTED BY LAW.

- 1. ELIGIBILITY:** The Conan SDCC Watch and Win Giveaway (“Promotion”) is open to legal residents of the fifty (50) United States and District of Columbia who, at time of game play, are at least eighteen (18) years of age and who are TBS cable subscribers as of July 17, 2019. Officers, directors, and employees (and their immediate families [spouses and parents, in-laws, siblings and children and their respective spouses, regardless of where they reside] and members of the same household of such, whether or not related) of Turner Entertainment Networks, Inc. (“Sponsor”); Prize Logic, LLC (“Administrator”); Team Coco Digital, LLC; TBS, Inc.; and their respective parents, divisions, affiliates, dealers, subsidiaries, advertising and promotion agencies and companies involved in the implementation and execution of the Promotion (collectively the “Promotion Entities”) are not eligible to play or win. Void in Puerto Rico and where prohibited or restricted by law.
- 2. PROMOTION PERIOD:** The Promotion starts on July 17, 2019 at 11:00 PM Eastern Time (“ET”) and ends on July 21, 2019 at 10:59:59 PM ET (“Promotion Period”). The Promotion Period consists of the following four (4) game periods (each a “Game Period”):

Administrator’s computer shall be the official Promotion clock.

- 3. HOW TO PARTICIPATE:** To participate in the Promotion, an eligible entrant must, during the Promotion Period, visit <https://Tbs.com/conan/pop> (“Website”) and provide his/her valid e-mail address, complete name (first and last, no initials), valid street address (P.O. boxes are not permitted), city, state, ZIP Code, and agreement to these Official Rules. During a Game Period, an entrant may watch the broadcast of CONAN, which airs on TBS at 11 PM ET on each Game Period start date listed in the table above (each a “Broadcast”). Note: Broadcasts are scheduled to re-air on the End Date of each Game Period at the following times: 12:30 AM ET (Game Period 1) and 12 AM ET (Game Periods 2, 3, and 4). During each Broadcast, a “Pop! Conan Code” (a “Code”) will be announced. There will be one (1) unique Code announced during each Broadcast and there will be a different Code for each Game Period. **A Code may only be used during the Game Period in which it is announced on a Broadcast.** During a Game Period, after obtaining a Code for the same Game Period, an entrant may then visit the Website and follow the instructions to enter the Code from the respective Game Period’s Broadcast to receive one (1) game play (“Game Play”). Upon receiving a Game Play, the entrant will receive notification on the Website screen whether he/she is a potential prize winner. Each entrant who receives a notification indicating that he/she has won a prize will be deemed a potential winner pending verification of the entrant’s eligibility and compliance with these Official Rules, as determined by Sponsor in its sole discretion. Sponsor will notify the potential Game Prize winners via e-mail at the e-

mail address provided when registering for the Promotion. If entering via mobile device, message and data rates may apply. Entrant should check his/her wireless customer pricing plan as carrier-specific charges for mobile usage may apply.

All potential winning Game Plays are subject to verification by Sponsor or Administrator, whose decisions are final and binding. 4. PRIZES, ODDS OF WINNING, AND APPROXIMATE RETAIL VALUE ("ARV"):

- a. Prizes (2,000 total; 500 per Game Period):** Each winner will receive a licensed Conan Funko Pop! Vinyl Figure (theme of figure will vary and will be determined by Sponsor in its sole discretion) ("Prize"). The approximate retail value ("ARV") of each Prize is \$9.99.
- b. Odds of Winning:** To be a Game Prize winner, an entrant's Game Play must have occurred at the exact randomly predetermined winning time as determined by Sponsor and/or Administrator or, if a Game Play does not occur at the exact randomly predetermined winning time, entrant's Game Play must be the first Game Play following the predetermined winning time. The number of Prizes available to be won will decrease during the Promotion Period as Prizes are awarded and claimed.
- c. Total ARV:** The Total ARV of all Prizes is \$19,980.
- d. General:** In no event will more Prizes than are stated in these Official Rules be awarded. Limit of one (1) Prize from each Game Period per person/household.

- 5. WINNER NOTIFICATION:** Potential winners are subject to verification of eligibility and compliance with these Official Rules. A Prize will be mailed to a winner at the physical address provided at the time of registration approximately six (6) to eight (8) weeks after verification. If a potential winner is found to be ineligible, is not in compliance with these Official Rules, or if a Prize is returned as undeliverable, the Prize may be forfeited. If a Prize is forfeited for any reason, it may be awarded to an alternate potential winner, at the Sponsor's sole and absolute discretion, selected at random from the remaining pool of Game Plays, time permitting. Approximate retail values are as of the time these Official Rules were printed and the value of a Prize may fluctuate. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR**

OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR PROMOTION ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
